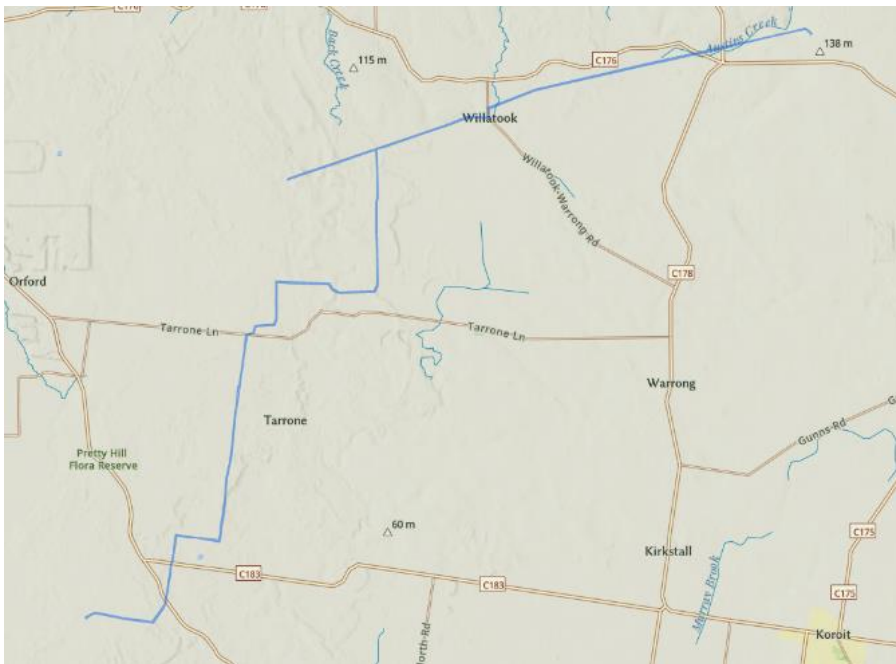
Community Open Days
