### **PROJECT NEWSLETTER – FEB 2018**

Hawkesdale Wind Farm is located in southwest Victoria, approximately 2 km south-east of Hawkesdale, adjacent to the Warrnambool-Penshurst Road in the Shire of Moyne.

Ryan Corner Development Pty Ltd (RDPL) is the proponent for the Hawkesdale Wind Farm project. RDPL is a wholly owned subsidiary of Global Power Generation Australia Pty Ltd (GPG Australia) [Previously called Union Fenosa Wind Australia Pty Ltd], GPG Australia is a subsidiary of the Spanish based Global Power Generation (GPG) that is part of the Gas Natural Fenosa group, a vertically integrated gas and electricity utility across 30 countries. The Hawkesdale Wind Farm was approved by the Minister for Planning under Planning Permit No. 20060221 on 12th August 2008. GPG proposed the following amendments to the permit which was approved on 21 December 2017:

- An increase in wind turbine height to a maximum of 180 metres (blade tip in vertical position).
- A minimum rotor blade sweep clearance above ground level for turbines of 30 and 40 metres depending on turbine location.
- A reduction of 5 turbines, resulting in a total of 26 turbines.
- Micro-siting of 12 turbines within 100 metres of the original approved location in accordance to provisions in the permit.

The increased turbine efficiency will enable the total number of turbines to be reduced, while enabling a greater output.

Additionally, RDPL lodged with DELWP an Application to Modify the existing Tarrone Terminal Station (TRTS), to accommodate the grid connection assets. This application has been granted by DELWP under delegation from the Minister for Planning on 12<sup>th</sup> February 2018.

## The Victorian Renewable Energy Auction Scheme (VREAS)

The Victorian Government has established the Victorian Renewable Energy Auction Scheme (VREAS) to support achievement of the Victorian Renewable Energy Targets (VRET). These targets seek to ensure that 25 per cent of the State's electricity generation comes from renewable sources by 2020, rising to 40 per cent of generation by 2025.

The 2017 VRET closes on 14<sup>th</sup> February 2018, in this auction, the Victorian Government will award commercial contracts in support of up to 650 MW of new renewable energy generation. Bids from renewable energy projects are to be submitted under a formal Request for Proposal (RFP).

GPG will submit a bid for Hawkesdale Windfarm, collaborating closely with Community and Council. Successful proposals will be awarded a 'Support Agreement' with the State of Victoria to ensure revenue certainty for renewable energy projects. An announcement on the successful bids will be made available in July 2018.

#### **Community Consultation**

GPG has recently appointed a Community and Stakeholder Engagement Manager who will be working closely with Landholders, Neighbours
