Hawkesdale Wind Farm

Project Status

- Wind farm planning permit:
 - ✓ The planning permit amendment has been approved and is available on the web site at <u>https://hawkesdalewindfarm.globalpower-generation.com.au/the-project/relevant-documentation/</u>.
 - ✓ Development and management plans required to be endorsed prior to the continuance of the schedule of works for construction have been submitted to the Minister for Planning for approval.
- Connection application & agreements:
 - ✓ Due Diligence Review of the connection application by AEMO in progress

Activities On Site

- Under progress:
 - ✓ The independent Road Quality Auditor has undertaken the preconstruction dilapidation report of nominated roads which will be trafficked by HDWF construction traffic to provide a fair and accurate baseline representation of the pavement condition.
 - ✓ Finalising project scheduling and access with associated landowners.
 - ✓ All of the components (blades, nacelles, hubs and rotors) arrived and are being stored and maintained at Portland.

Transmission Line and Tarrone Terminal Station

- ✓ Foundations for the new 500kV switch gear at Tarrone Terminal Station are complete.
- ✓ Works on the 132kV switchyard at the Tarrone Terminal Station are progressing with foundations almost complete.
- Transformer yard earthing started whilst new fencing starting to be erected.
- The Native Vegetation Removal Permit for the transmission line will be submitted to the Department of Environment, Land, Water and Planning for assessment.
- \checkmark The final geotech surveys for the transmission line are still to be completed
