# Hawkesdale Wind Farm

### Project Update

- Planning permit 20060221-2 has been extended to 31 December 2024
- All the components (blades, nacelles, hubs and rotors) are being transported from Portland to Hawkesdale

# Activities On Site

- 3 turbines have been fully erected and 5 are at pre installation (first tower section)
- 20 turbine foundations have been completed
- Construction of access tracks continues with approximately 100% trafficable
- The laying of the underground interconnection cables is completed
- The substation bench has been completed, the operations buildings are under construction and the switch room has been delivered

# Supporting Western District Food Share

The call from Western District Food Share for assistance to provide breakfast goods and other snacks to the local schools prompted GPG Australia to initiate a food drive at Ryan Corner and Hawkesdale wind farms. Together with GPG the contractors collected 353kg of packaged food including cereals, muesli bars, spreads, milk and other breakfast staples. The workers at both wind farms were quick to respond with most of the items collected in a few days. Many of the staff and workers live locally and have children who attend the local schools. It is important to GPG and all involved in the construction of the wind farms that the young people in the community are receiving good food during the school day.

# Are you prepared for the fire season?

The fire season is approaching and the CFA have declared the first Fire Danger Period in Eastern Victoria. The Hawkesdale wind farm project is working to ensuring a safe construction site during this summer. In line with the Bushfire Emergency Response Plan (BERP), regular inspections are conducted on all fire safety mechanisms such as extinguishers, water tanks, fuel storage and vegetation control. Hawkesdale wind farm is happy to be hosting the local brigades for their pre fire season exercises and having an opportunity to familiarise them with the site.

### Turbines and fire suppression

The Vestas turbines that are being installed at Hawkesdale wind farm are model V136 4.2 MW. With each model turbine that is released the technology used is advancing. This model turbine has an advanced fire suppression system that is activated by smoke and arc detection. This runs through a separate safety system and is independent from the control system of the turbine.

## Harry Sherlock – Turbine erection supervisor

Harry was born locally in Penshurst, the eldest of 6 siblings, receiving primary schooling there and secondary in Hamilton. During those years he was also involved playing football at Penshurst and Hamilton Imperials.

After leaving school, he started a boiler making apprenticeship at Thornton Engineering in Penshurst and moved to Geelong to continue working with that company for 20 years. He then started working at Geelong Port as a maintenance supervisor.
