# Hawkesdale Wind Farm

## Project Update

- Planning permit 20060221-2 has been extended to 31 December 2024
- All the components (blades, nacelles, hubs and rotors) are being transported from Portland to Hawkesdale

### **Activities On Site**

- 6 turbines have been fully erected and 10 are at pre installation (first tower section)
- All turbine foundations have been completed
- Construction of access tracks 100% trafficable
- The laying of the underground interconnection cables is completed
- The substation bench has been completed, the operations buildings are under construction and the switch room has been delivered


